

# Call out: Bright & Wild Music Artist Commission 2021/22

Job Title: Lead Artist - Music

**Reports to:** Projects and Engagement Manager **Contract:** Fixed Term Freelance, 9 months

Hours: Weekly sessions for 3 Terms covering 27 weeks, plus 3 days preparation/planning and 5

days in production week. (i.e. 35 days at £150 per day)

Location: Artspace, 11 Harewood Road, Edinburgh EH16 4NT and throughout the Greater

Craigmillar area. Meetings may also take place online.

# **Bright & Wild Commissions**

Lyra is looking to commission an experienced Music Artist to create a new performance piece for the 2022 Bright & Wild festival in collaboration with children and young people from Greater Craigmillar in Edinburgh (Lyra's Young Artists). This Commission is part of our exciting project, *Connections* funded by a National Lottery Community Fund Young Start Grant.

## The Commission includes:

- Lead Artist fee of £5,250
- A budget of £2,000 for materials and collaborators
- Free theatre and studio space at Lyra
- Free hot desk office space at Lyra
- A Facilitator and Youth Arts Worker to support the sessions
- Producer support
- Opportunities to share the progress of the work with audiences and industry professionals

## The Role

## The successful Music Artist will be:

- able to work with a mixed ability group of young musicians (mostly beginners, aged 8+)
- skilled in teaching music through non-traditional methods (e.g. colour strings or similar)
- able to present and realise an exciting, high quality idea for an end of project performance.
- educated to a degree level in music or have equivalent professional experience.
- passionate about creating music performance with children and young people.
- able to manage their commission budget (with support from the Lyra team)



## Who can apply?

Artists from any music performance background are welcome to apply. Cross-disciplinary proposals from independent artists, collectives or companies are also welcome.

The commissions are suited to Artists who live in/close by to Edinburgh. We can subsidise travel costs up to a maximum of £500 per person for those living outside of the City of Edinburgh.

## The Group

The Youth Music group is a mixed ability group of around 10 participants, aged 8+. They do not need to have prior experience of music to join in. Most participants are therefore at beginner level. Usually, this group works with a band set-up using Lyra's music resources which include: keyboards, acoustic guitars, drums, microphones, and a variety of percussion instruments.

## **Weekly Sessions**

The successful Music Artist or a collaborator will lead weekly rehearsals to develop the Music Artist's concept with the Young Music group on Saturday afternoons for 2 hours (plus 30 minutes briefing and debriefing before and after the live session) from **September 2021 - June 2022**. The final performances will be presented in the **w/c 13th June or w/c 20th June 2022**.

The weekly sessions run in line with the school calendar. Additional rehearsals and development time can also be arranged as needed.

We understand that freelance Artists will be balancing a number of projects. Applicants should be available for the majority of the dates, however, the materials/collaborators budget can be used to bring in other Artists to cover sessions for weeks when the lead Artist is working elsewhere.



## **How to Apply**

As a child-centred organisation, Lyra's Young Artists choose the Music Commission they want to work on. Please make sure your application is child-friendly and can be easily understood by an 8 year-old!

## Stage One: Tell Us About You and Outline Your Idea

Please submit:-

- vour CV
- a 500 words outline of your idea
- 3 examples of your work to date (we welcome you to submit images/links)

We welcome applicants to think outside the box when putting their proposal together.

We would also be grateful if you could complete our **Equal Opportunities Monitoring Form** when you submit your application. You can find the form HERE.

#### Stage Two: Expand on Your Idea

Shortlisted Applicants, from Stage One, will be invited to expand on their idea and submit a full proposal of no more than one A4 page or 3 minutes of audio/visual footage.

Remember your proposal will be read/listened to/watched by the Young Artists (aged 8+) and they will make the shortlisting decisions.

## **Stage Three: Pitch Your Idea to the Young Artists**

Applicants shortlisted by the young people, from Stage Two, will be invited to lead a **practical workshop** with the Young Artists, where they will have the opportunity to pitch their idea. Applicants will be paid for this workshop.

The Young Artists will vote for their preferred idea after the practical workshops.

Workshops will take place in the w/c 13th September 2021.

## **Diversity and Inclusion**
